

## Sacred Heart Academy 2025-2026

## ACCEPTABLE USE POLICY

Computer use and Internet access is encouraged and made available to further education and research in an academic setting consistent with the mission of the Diocese of Arlington, Office of Catholic Schools. Computer and Internet access may be used only for academic purposes. Internet access is provided at times and places determined by each school under the direction and supervision of the school staff. Files stored on school computers are restricted to school-related assignments only. Telecommunication is restricted to school-related projects and must be supervised by the teacher and/or staff.

The Internet contains extensive information on a variety of subjects. There is no privacy on the Internet; therefore, personal or identifying information should not be provided concerning anyone in the school. Many laws, including those related to copyright infringement, harassment, slander and obscenity apply to Internet use.

The Diocese of Arlington administrators, faculty, and staff have the right to restrict student computer activities at any time if, in their judgment, a student is not following the spirit of the Diocese of Arlington and/or Sacred Heart Academy's Acceptable Use Policy. Students attending Diocesan schools are prohibited from using school or personal computers or electronic devices for any of the following activities: (This list is not meant to be all inclusive.)

- 1. I will not intentionally damage the computer/device or network in any way. I understand that cosmetic damage to school devices will result in a personal charge to my family FACTS account.
- 2. I will not use a computer or handheld device to harm other people or their work.
- 3. I will not view, use, or share other people's folders, files, passwords or work.
- 4. I will not view, send, share, or display offensive or inappropriate messages or pictures.
- 5. I will not use technology to harass, threaten, deceive, intimidate, offend, embarrass, or annoy any individual
- 6. I will not use school equipment to duplicate (or burn) any software or media files.
- 7. I will not photograph and/or use audio/video recording capabilities with any electronic device for personal use, with or without the knowledge and consent of an individual.
- 8. I will not view Internet sites that my school or teacher does not allow or think are inappropriate.
- 9. I will not misrepresent myself or use the image or likeness of another person.
- 10. I will tell any adult immediately if I see materials that violate these rules.
- 11. I will not access my personal email account or any free email services.
- 12. I will not record any personal information, such as name, address, etc., about myself for anyone else on an Internet site.

- 13. I will not view Internet sites that my school or teacher does not allow or thinks are inappropriate.
- 14. I will not access the internet for private or commercial business.
- 15. I will not access, produce, transmit and/or retransmit material especially that which advocates or promotes violence or hatred against individuals or groups, promotes destruction of property or contains inappropriate materials.
- 16. I will not hack or infiltrate the school or outside computer accounts, or networks, or attempt to establish contact into school restricted computer nets or any other unauthorized databases. Users will not access, transmit, and/or retransmit material requiring a password or security authorization without legally possessing such password or authorization.
- 17. I will not commit or attempt to commit any willful act which disrupts the operation of any school, outside computer or network for example, users will not release viruses, worms, spam, email bombs, or other files that cause a disk to fill up, a network to bog down, or a software application to crash.
- 18. I will not play games, gamble, surf, chat, enter chat rooms/gaming chats or other online messaging pages, stream video or music, visit social media or shopping sites, or participate in similar nonacademic use.
- 19. I will not send, store, or intentionally receive email or text messages of any kind.
- 20. I will be polite, respectful, and charitable, and all communications will not contain obscene, vulgar, degrading, or defamatory language.
- 21. I will not harm the goodwill and reputation of the school or school employees.
- 22. I will not bring any electronic device from home into school for use without prior approval from the school's administration.
- 23. I will not modify the school computers by downloading and/or installing software that will add/delete and/or change the software, setting preferences, properties, or account customization (Including copyrighted software, shareware and freeware).
- 24. I will not transmit any material in violation of any local, state, or federal law. This includes, but is not limited to: copyrighted material, licensed material, pornographic material, and threatening or obscene material.
- 25. I will not represent other people's work as my own (plagiarism).
- 26. I will tell any adult immediately if I see materials that violate these rules.

## Artificial Intelligence (AI) Policies

- 1. I understand that permission and supervision by a teacher or school administrator is mandatory to use AI tools.
- 2. I understand that many AI programs require users to be at least 13 years of age for use and will refrain from the underage use of AI programs.
- 3. I will only use AI technologies to create and consume content that is appropriate and approved by the school for an educational environment.
- 4. I understand that creating or viewing content that is offensive, discriminatory, or violates school policies is strictly prohibited.
- 5. I will adhere to Sacred Heart Academy policies and will never present content generated by AI as my own work.
- 6. I will not use AI to manipulate materials, photos, videos, etc. that do not belong to me or that include the image and likeness of other people.

7. I will use AI technologies in a respectful and responsible manner, treating others with Christian charity and consideration in both virtual and physical interactions.

## **Student:**

I understand any violation of the above provisions will result in the loss of my user account and may result in further disciplinary and/or legal action, including but not limited to suspension or expulsion, or referral to legal authorities. I therefore agree to maintain acceptable standards and to report any misuse of the system to the appropriate teacher or administrator.

Misuse or violation of this agreement comes in many forms, but can be viewed as any messages, information or graphics sent or received that include/suggest inappropriate images, unethical or illegal solicitation, racism, sexism, inappropriate language and/or other listings previously described in this user agreement. I agree to report any misuse of the electronic information resources to the appropriate teacher or administrator.

I have read this Acceptable Use Policy and understand that Internet sites are filtered and that Internet use on my school computer may be monitored. I understand that all electronic files are subject to review by the administration. I have read this Acceptable Use Policy and hereby agree to comply with the above described conditions of acceptable use.
